BENEFICIARY DESIGNATIONS

Did you know you can create a legacy without changing your will or parting with any of your assets during your lifetime? One of the easiest gifts you can make is to name Western Michigan University Foundation as a beneficiary to one of the following assets:

IRAs and Other Qualified Retirement Plan

Designations: You can designate Western Michigan University Foundation as the ultimate or partial beneficiary of a retirement account, such as an IRA or 401(k). To do so, complete a beneficiary designation form and return it to the plan's custodian. When left to heirs, these assets are heavily taxed. "Beneficiary Designations" offer built-in peace of mind.

Your current budget isn't affected; plus, you can change your mind at any time.

Life Insurance: Name Western Michigan University Foundation as a beneficiary of an existing life insurance policy if your family no longer needs the benefits. Complete and return the form designating the Foundation as the recipient of all or a portion of the policy benefit. Life insurance can provide a significant gift at a low cost to you.

Payable on Death (POD) and Transfer on Death (TOD) Accounts: A POD or TOD account allows for the money remaining in an account, when the account owner passes, to go directly to the beneficiaries named. POD/TOD designations can be created for most bank and investment accounts and for certificates of deposit and U.S. savings bonds. Simply complete a form instructing your bank or account administrator to distribute all or a portion of what remains in your account at the end of your lifetime.

Donor-Advised Fund Designations: In most cases, you can recommend in advance (on a form provided by the account manager) that at the end of your lifetime a lump-sum grant be made from your donor-advised fund account to a charity. Check your donor-advised fund's policies and guidelines to confirm the steps necessary to make this gift.

These options not only allow you to give, but also provide you with peace of mind should you ever need to access your assets.
